The School recognizes within our community that at times parent(s) are required to travel away from home overnight or for extended periods of time. Therefore, AISJ has outlined a process to assist parents who encounter this challenge and to ensure that legalities are covered so that parents are legally compliant with the laws governing temporary guardianship. Families must complete the form below prior to their travel and notify the respective divisional offices. It is required that the family send the respective office a copy of the guardian's SA valid identification or a valid passport. The guardian must reside in Gauteng while undertaking the temporary guardianship.

It is preferred that the student reside with the temporary guardian during the parents('s) absence. There must be adult supervision where the student is residing.
